Formatting the text

The text of your paper should be formatted as follows:

- 12-point Times New Roman.
- The text should be set to single-line spacing.
- Paragraphs should be justified.
- The first paragraph after a section or subsection heading should not be indented; subsequent paragraphs should be indented by 5 mm.
- Single tab for all paragraph

Page Setup

The top margin (2.54 cm/1 inch), bottom (2.54 cm/1 inch), left (2.54 cm/1 inch); and right (2.54 cm). Papers should be printed on A4 size paper (21 x 29.7 cm).

Structure

The file should be prepared in Microsoft Word format only and should be ready for printing. Figures, tables, and equations must be embedded in the text. Make sure that author uses Times New Roman in the whole document write-up. Full-length article should follow this order: Title, Authors name and affiliation, Corresponding authors email, Abstract, Keywords, Introduction, Materials and Methods, Results and discussions, Conclusion, Acknowledgement, References, and Appendix (optional).

4. Section Headings



6. Figures

All figures should be numbered with Arabic numerals. All photographs, graphs and diagrams are to be referred to as figures. Line drawings should be good quality, low-quality scans are not acceptable. Figures must be embedded into the text and not supplied separately. Figures should be placed at the top or bottom of a page wherever possible, as close as possible to the first reference to them in the paper.

In general, try to avoid extremely fine lines (often called 'hairline' thickness) because such lines often do not reproduce well when printed out—your diagrams may lose vital information when downloaded and printed by other researchers. Try to ensure that lines are no thinner than 0.25 pt. Note that some illustrations may reduce line thickness when the graphic is imported and reduced in size (scaled down) inside Microsoft Word.
